



RESIDENTIAL INSULATION REBATE - Program Participation Guidelines

HOMES THAT QUALIFY FOR A REBATE

- Existing Site-Built and Manufactured homes are both eligible.
- Homes must be occupied year-round; seasonal homes and homes with part-time occupancy are *not* eligible.

REBATE AMOUNT

SITE BUILT INSULATION REBATES

<u>Type</u>	<u>Existing Insulation</u>	<u>Final Insulation</u>	<u>Rebate –per sq. ft.</u>
Attic	R-0 TO R-11	R-38, R-49	0.65
Attic	R-11 TO R-19	R-38, R-49	0.25
Attic	R-20 TO R-31	R-38, R-49	0.10
Floor	R-0 TO R-11	R-19, R-25, R-30	0.25-0.30
Floor	R-12 TO R-19	R-30	0.05
Wall	None	R-11	0.65

MANUFACTURED HOME INSULATION REBATES

<u>Type</u>	<u>Existing Insulation</u>	<u>Final Insulation</u>	<u>Rebate –per sq. ft.</u>
Attic	R-0 TO R-7	R-22 +	0.30
Attic	R-0 TO R-11	R-30 +	0.25
Attic	R-12 TO R-17	R-30 +	0.10
Floor	R-0 TO R-7	R-11, R-22 +	0.30
Floor	R-8 TO R-11	R-22 +	0.20

Rebate amounts are listed as “up-to” and may vary by insulation ratings, location, and type of heat

INSTALLER REQUIREMENTS

- Installation is not required to be completed by a contractor.

BEFORE INSTALLATION: PRE-APPROVAL

- An on-site visit is *not* required prior to installation to qualify for the rebate, however if installation is not being performed by a licensed contractor, pre-installation photos are required.
- Rebate Applications must be submitted within six (6) months of purchase/installation to qualify.

AFTER INSTALLATION: FINAL DOCUMENTATION

- You or your contractor must submit a completed Insulation Rebate Application and “paid” invoice.
- If a registered OCCB contractor installs the insulation, they must provide reports documenting pre and post insulation conditions, including location of installation, square footage and area covered.
- If project is not completed by a licensed contractor, pre and post photographs are also required.
- **All required documentation must be included with application for rebate to be paid.**

QUALITY ASSURANCE INSPECTION

- Coos-Curry Electric may do a pre or post installation inspection of your insulation project.

REBATE PAYMENTS

- Please allow 6-8 weeks for payment after receipt of all required documentation.
- All rebates will be paid in the form of a credit to an active member account.
- Please ensure to specify the correct account number in your application to where credit should be applied.
