The selected Coos-Curry Electric Cooperative, Inc.'s delegate must agree to be available to attend the NRECA Youth Tour in Washington, D.C. June 17 - 24, 2020. This is an all-expense-paid trip, with the exception of spending money.

To be eligible for the competition, students must:

- Be in the 11th grade during school year 2019/20.
- Live in the home of a parent or legal guardian who is an active Coos-Curry Electric Cooperative member living in CCEC's service area.
- Be able to participate in the tour to Washington, D. C., June 17-24, 2020.
- Submit the completed
 - Application (This form is fillable PDF to make it easy to type)
 - Video Essay
 - Due to CCEC **by 5:30 p.m., Thursday, January 16, 2020.**
- Be able to attend a personal interview (date, time and location to be determined).
- The selected delegate may be asked to conduct a presentation to the CCEC Board of Directors and/or create a short video summary after the trip.
- Write up a summary after the trip to be published in Ruralite Magazine.
- Your photo may be published in print material and online.
